

NOMADS LICENSING AGREEMENT

This is an agreement which licenses VENDORS to use the NOMADS logo and produce and sell merchandise to individuals who are members of UNITED METHODIST NOMADS.

I. LICENSOR is UNITED METHODIST NOMADS, a New York non-profit corporation with its principal place of business at P. O. Box 3508, Shawnee, KS 66203, hereinafter NOMADS.

II. VENDOR is _____ whose address is set forth below.

III. NOMADS and VENDOR agree as follows:

A. NOMADS represents that it is the owner of the logo set forth below and that NOMADS has the exclusive right to use this logo and to license others to use this logo.

- 1. NOMADS recognizes that the “cross and flame” is a trademark of the United Methodist Church and its use by NOMADS is a representation that NOMADS is affiliated with the United Methodist Church.



- B. NOMADS desires to protect this logo, but will grant limited use to VENDOR.
- C. NOMADS agrees to allow VENDOR to use the logo of NOMADS for the sole purpose of producing and selling merchandise displaying the NOMADS logo to members of NOMADS. NOMADS has the right to inspect merchandise on which the logo is used and to approve or disapprove the appropriateness of the merchandise.
- D. This license is not an exclusive license and NOMADS retains the authority to license

the NOMADS logo to others on the same or different basis.

E. Both parties have the right to terminate this agreement upon sixty (60) days notice to the other and NOMADS has the right to terminate this agreement upon five (5) days notice for cause.

1. Cause for termination shall mean failure to abide by the terms of this agreement, failure to accurately produce logos on merchandise and the use of the logo on any merchandise which, in the NOMADS Board of Directors opinion, produces a negative image for NOMADS.

F. VENDOR agrees to be bound by the following:

1. VENDOR will pay a one hundred dollar (\$100.00) fee with its application and shall pay a twenty-five dollar (\$25.00) annual fee due on the anniversary date of this agreement for its right to be a VENDOR for NOMADS and to continue on an annual basis.

2. VENDOR shall not have the right to license the use of the logo to any other person or entity.

3. VENDOR shall have the right to all proceeds of sales.

4. VENDOR agrees that no other logo or trademark shall be used in conjunction with the NOMADS logo, but the name of the individual NOMADS member may be placed on the merchandise.

G. NOMADS agrees that, once approved and licensed, VENDOR is entitled (at no additional cost) to a small link to VENDOR's website and a small listing of VENDOR's name, address and business in each newsletter so long as the license agreement is in effect.

IV. This agreement shall be in force for one year from the date of execution by NOMADS and shall continue to be extended annually upon the payment of the annual license fee. The agreement shall remain in force and effect so long as payments are made unless terminated sooner by either party.

IN WITNESS WHEREOF, the parties hereto sign this document signifying their agreement to the terms set forth herein.
